



AGNC Investment Corp. Declares Monthly Common Stock Dividend of \$0.12 per Common Share for March 2021 and Announces Estimated Tangible Net Book Value of \$17.51 per Common Share as of February 28, 2021

(Nasdaq: AGNC) ("AGNC" or the "Company") announced today that its Board of Directors has declared a cash dividend of \$0.12 per share of common stock for March 2021. The dividend is payable on April 12, 2021 to common stockholders of record as of March 31, 2021.

The Company also announced today its estimated tangible net book value of \$17.51 per common share as of February 28, 2021. The estimate of tangible net book value includes a deduction for the Company's February 2021 dividend of \$0.12 per common share, which was declared on February 11, 2021 with a February 26, 2021 record date.

The estimated tangible net book value is unaudited and has not been verified or reviewed by any third party. The Company's current estimate may also be materially different from its estimate as of February 28, 2021. The Company undertakes no obligation to update or revise its estimate of tangible net book value.
