

# American Capital Agency Corp. Declares Monthly Common Stock Dividend for December 2014 and Announces Estimated Net Asset Value as of November 30, 2014

(Nasdaq: AGNC) ("AGNC" or the "Company") announced today that its Board of Directors has declared a cash dividend of \$0.22 per share of common stock for December 2014. The dividend is payable on January 9, 2015 to common shareholders of record as of December 31, 2014, with an ex-dividend date of December 29, 2014.

The Company also announced today its estimated net asset value ("NAV") of \$25.74 per share of common stock as of November 30, 2014. The estimated NAV as of November 30, 2014 is net of the Company's November 2014 common stock dividend, which was paid on December 5, 2014. The estimated NAV as of November 30, 2014 is unaudited and has not been verified or reviewed by any third party. The Company's current NAV may also be materially different from its estimated NAV as of November 30, 2014. The Company and the Company undertakes no obligation to update or revise its estimated NAV.
