On April 22, 2021, AGNC Investment Corp. (the "Company") held its 2021 Annual Meeting of Stockholders (the "Annual Meeting"). The record date for the Annual Meeting was February 26, 2021. As of the record date, a total of 531,122,179 shares of the Company's common stock, par value \$0.01 ("Common Stock"), were entitled to vote at the Annual Meeting. There were 402,403,224 shares of Common Stock present in person or by proxy at the Annual Meeting. Set forth below are the matters acted upon by the common stockholders and the final voting results of each such proposal.

1. Election of Directors. The Company's common stockholders voted to elect seven (7) Director Nominees to hold office for a term of one (1) year and until his or her successor is duly elected and qualified.
